Terms and Conditions for Rent of Buddhist Hall / Other Lecture Halls

1. Only Institutional Members of SBF may rent the Buddhist Hall/ Lecture Hall for Dharma propagation.
2. Should there be more than one applicant for the same date / time, allocation will be on first-come-first served basis (upon receipt of payment).
3. Applicant shall observe the following:
 - (1) No meat, fish, wine, liquor, gambling or any contraband items is allowed in the hall or any place within the SBF premises.
 - (2) Activities that are not in conformity with true Buddhism shall not be conducted in the hall or any place within the SBF premises.
 - (3) No political or trade union activities or gathering shall be conducted in the hall or any place within the SBF premises.
 - (4) No blasphemy of any religion or immoral conduct is allowed.
 - (5) Applicant shall be responsible for application of relevant permit or licence for their intended activities if needed and shall furnish a copy of such permit or licence to SBF. *
 - (6) Applicant shall be responsible for application of relevant permit or licence for display of banner, poster or advertising materials and shall furnish a copy of such permit or licence to SBF.*
 - (7) Applicant shall be responsible for application of relevant permit or licence for any guest speaker and shall furnish a copy of such permit or licence together with a copy of synopsis and CV of the speaker. *
- *Failure to produce relevant permit will cause the application be rejected.
4. SBF reserves the right to decline any application without stating any reason.
5. SBF reserves the right to vary the terms and conditions and rental rates as and when it deems necessary
