 - (5) 没有被判入窃籍者

TERMS AND CONDITIONS ON MEMBERSHIP APPLICATION

- 1. Only Buddhist institution registered under the Societies Act or other relevant law in Singapore may apply to be an Institutional Member.
- 2. The Authorized Representative of the institutional applicant must meet all the following requirements. He or she must;
 - (1) be at least 21 years old and be a Singapore Citizen
 - (2) be a Sangha member or lay Buddhist;
 - (3) be a member of the Executive Committee or Management Committee or Council or Board of Directors or Principal Executive of the institutional applicant;
 - (4) not have been convicted under the criminal law of any country and
 - (5) not be an un-discharged bankrupt.
- 3. Applicant must be sponsored by 2 incumbent Council Members of the Singapore Buddhist Federation (SBF) and duly signed.
- 4. The following documentary evidence must be summitted together with the application:
 - (1) Certificate of ROS/ACRA registration;
 - (2) Ordination or Refuge Taking Certificate of the Authorized Representative; and
 - (3) Birth Certificate of the Authorized Representative
- 5. Completed form must be accompanied by cheque payment totaling \$165 , \$110. being entrance fee and \$55 for first year's subscription, and made payable to "Singapore Buddhist Federation" and sent to:
